

**NATIVE MAGISTRATES.**—The investing of the leading talookdars of Oude with magisterial and revenue powers, must be considered a success, as Government had increased the number who already exercise these powers by about twenty. The Rajah of Kupporthulla is to have the full powers of a magistrate and collector, and the Maharajahs Drigbijye Singh and Man Singh, and several others, are vested with the special powers of an assistant magistrate and collector on their several estates.

**THE NICHOLSON MEMORIAL.**—A correspondent informs the *Delhi Gazette* that the Nicholson Testimonial is to be erected at Margulla in the form of an obelisk. An artesian well is to be bored in the pass, to supply travellers with water.

**SHIPPING INTELLIGENCE.**—Several vessels had been obliged to put back, on account of the unsettled state of the weather at the Sandheads. The *Gloriana*, bound for London, with troops on board, was obliged to put back from stress of weather. The schooner *Shirazee* also put back from the same cause. The *Clasmerden*, bound to New Orleans, was unable to put her pilot on board the brig at the Sandheads, and has proceeded on her voyage. The *Lafayette*, from the Mauritius, grounded off Hooghly Point, and was a complete wreck.

**WANT OF COPPER COIN.**—The want of copper coin continued to be severely felt throughout the North-West Provinces, and the Punjab Government had called the attention of the Supreme Government to the fact that in some places, particularly Peshawar, the pressure was so great and the loss to the soldiers becoming so serious, that unless copper was speedily sent, the evil would have to be mitigated by some direct interference. Orders had been issued for a speedy supply of copper coin being forwarded.

**THE SEAT OF GOVERNMENT OF THE N. W. PROVINCES.**—It was said that Mr. Wilson had refused to sanction the necessary outlay, three lakhs, for building Government offices at Allahabad, and an early return to Agra of the head-quarter offices of the Government of the North-West Provinces was therefore expected.

**THE CAWNPORE MEMORIAL CHURCH.**—The subscriptions to the Cawnpore Memorial Church amounted to 40,049 rupees.

**THE INDIGO PLANTERS AND THE RYOTS.**—An extract from Dr. Mouat's report regarding the indigo planters and their treatment of the ryots under them had been published. Dr. Mouat states that the real oppressor is the native zemindar, who, like the Irish landlords, is generally absent from his estate, and whose aim and object is to endeavour to extort as much rent from his unfortunate ryots as he possibly can.

**ASSAULT ON A MISSIONARY.**—The Rev. Mr. Broadway was preaching at the Calcutta Gate of the city of Delhi, when a sepoy of the police corps, at the instigation of some Mussulman bystanders, rudely interrupted him. Mr. Broadway desired the man not to interfere, when he was assaulted by him, the sepoy tearing off the reverend gentleman's coat, while pushing him towards the havildar at the gate. The sepoy was fined ten rupees for the assault in the assistant commissioner's court.

**RAVAGES OF WOLVES IN OUDE.**—The ravages of wolves in Lucknow still continued to an alarming extent. They not only carry away children, but two cases had occurred in which grown-up women had been devoured by these ravenous beasts. Every attempt made to entrap them had proved unsuccessful. Shekarries had also been employed. The rewards for their destruction had been increased, but with no better result. The *Oude Gazette* states that a couple of labourers were lately engaged in digging a well, when the earth gave way, and they were buried alive. They were soon after dug out, but life had already become extinct. Among those who attempted to save their lives was an old woman, whose humane occupation prevented her from returning home before nightfall. Her child, about seven years old, was asleep on the threshold of the hut where she lived, and a wolf, during the mother's absence, carried off her child.

**TORTURE IN OUDE.**—Cases of violent assault and torture were prevalent throughout the province of Oude. An instance is related where two victims had had their arms so tightly bound, that circulation was stopped, and they were then placed in the sun. The arms of these unfortunate men had mortified, and they were not expected to live. The police had apprehended several of the offenders.

**THUGGISM IN THE OONAO DISTRICT.**—Two or three cases of Thuggism had occurred in the Oonao District. Major Chamberlain had apprehended some of the offenders.

**REBELS IN OUDE.**—The following is from Cawnpore, dated 25th June:—"The utmost secrecy prevails at this station about the rebels being in force about 80 miles from this on the other side Calpee, and one regiment has marched from hence, and another held in readiness. I hear there are about 4,000 banded together, and they have plundered several villages."

**JEYPOOR.**—We hear from Rajpootana that one of the chiefs of Boondee who found refuge in Jeypoor has given much trouble by his excesses; he has collected forces, and set the authority of the Rajah of Jeypoor at defiance. This chief is the Thakoor of Zetra in Harotee. The Rajah of Jeypoor has warned the village zemindars of the danger of giving this man shelter, and has threatened all with severe punishment if they help him with supplies, or refuse to give information regarding him.

**THE RAJAH OF PACHETE.**—The Rajah of Pachete having lost all patience, had informed the authorities that he intends prosecuting them in the Supreme Court for false imprisonment.

**THE WILL FORGERY CASE.**—The notorious will forgery case, in which Sibkissen Bannerjee, Dr. Crawford and another, were concerned, had again been before the Calcutta Supreme Court. A new trial was moved for, mainly on the ground of irregular conduct on the part of some of the jury. The convicts were meanwhile detained till the result was known. Sir Mordaunt Wells concurred in the judgment delivered by the Chief Justice, that the application could not be entertained. The convicts had accordingly sailed, heavily ironed.

**THE STATE OF SHAHPOORA.**—The small State of Shahpoora, in Ajmere, is said to be very badly managed at present by the young chief, and the attention of Government had been called to its affairs by the Agent. The Lieutenant-Governor of Agra had instructed the Agent to endeavour, by advice and kindness, to lead the young man to understand the interests of his country and his own, and to warn him of the serious consequences of neglecting the counsel.

**THE "ACCRINGTON."**—The unfortunate ship *Accrington* had at length arrived at Calcutta. A committee of officers had been ordered on board to report upon the state of the soldiers' wives and children. She was commanded by an officer of H.M.'s navy, who was put on board by the British Consul at Pernambuco.

**THE EX-KING OF OUDE.**—The *Englishman* states that the King of Oude was still surrounded by several persons who were implicated in the rebellion. The danger of allowing these men to remain had been notified to the King, and the police authorities of Calcutta had been warned to keep a watchful eye over the movements of these men, who are well known to Government.

**THE PUNISHMENT OF PERJURY.**—Several "native gentlemen, merchants, shopkeepers, and inhabitants of Calcutta," had addressed a petition to the Lieutenant-Governor of Bengal deprecating the severity with which the judges of the supreme court punish perjury. Imprisonment for the offence rarely if ever exceeded two years before, now it is visited with transportation for seven years. The petition was in reality one for the liberation of two prisoners who were sentenced to seven years' transportation last sessions. The chief argument of the petitioners was that perjury is a native crime, and that to punish it so severely was to favour the Europeans. So long as such petitions as this can be written and boldly sent up to Mr. Grant, we fear the hope of preventing perjury in the courts by any means whatever, is very distant.

**GOVERNMENT PRINTING.**—The Governor-General had directed a careful inquiry to be made into the working of the official printing departments scattered, at present, all over Calcutta. Colonel Bal-four, C.B., Mr. H. D. Sandeman, Captain Dickens, and Mr. Kellner, had been appointed a committee to conduct it, with the view of contrasting the cost of many separate offices with a great central department like that at Madras and Allahabad, and of determining whether there should be only one such office in Calcutta. At present, every department has its head printer on 400 rs. a month, and all compete with each other for workmen. The work is done imperfectly and slowly, and, as in the telegraph department, the privilege of printing any documents, however long or trifling, is abused.
