I have the honor to forward in original for orders by the Hon^{ble} the Lieutenant Governor a letter to my address from Comdr. Bellie N^o 285 of 2nd instant reporting that owing to the omission to fix a date for the commencement of the pension of P. A. 285 N. B. P. A. to which the sanction of the Supreme Government was conveyed by yours N^o 1217 of the 5th November last, some doubt has arisen as to the date from which this pension should be held to commence.

2. It was granted to compensate for the resumption of an apportionment of two Sahib villages which he possessed in the Pothohar district. He has not drawn anything from them since the end of 1856/57. The whole amount for 1857/58, and subsequent years has

has been brought to the credit of the
State. Mr. Brauchett recommends
that the orders of the Supreme Gov-
ernment be construed into a direc-
-tion for the continuance of the grant-
and so would make it to begin from
1st May 1857 but in my opinion,
under the orders of the late Board
of Administration as embodied in
Circular of this Office N^o. 74 of 1857
the payment should be held to
commence from 1st March 1857.

3 — I request therefore that the
orders of the Supreme Government
on this point may be obtained.
